Terms and Conditions for Virtual Education

- Three (3) virtual continuing education programs will be offered for the 2023 Convention. These activities will be three (3) contact hours in a "webinar" mode.

- **Once you access the webinar, you will not be able to request a refund or any change.**
- Once enrolled in the virtual Continuing Education, you will not be able to attend the face-to-face one.
- Any change in virtual Continuing Education must be made according to the Continuing Education General Rules and depending on availability of the course.

**Cancellations
(Conference Pre-registration)**

There will be no cash refund when cancelling your registration; credit will be awarded for use in future continuing educations. For this, you must submit written justification indicating the reason why you were not able to attend the conferences and evidence, if required.

Cancellations or changes must be made on or before Tuesday, August 1st, 2023 for an **80% refund of the total amount paid**. The remaining 20% will be used for clerical expenses. After Tuesday, August 1st, 2023 no refund requests will be accepted for NOT attending educational activities.
